- Equipment installations must meet our **Minimum Efficiency Requirements** to qualify for a rebate. Air-Conditioning, Heating, and Refrigeration Institute (AHRI) and ENERGY STAR® standards are used. (Please refer to the appliance or equipment section of this rebate form for requirements and reference sources.)
- **Due to limited funding, this rebate offer can be withdrawn at any time without notice. Applications will be processed on a first-come, first-serve basis. All applications from the previous year's purchases must be received by March 31.**
